- Between FY 06/07 and FY 11/12:
  - Average growth of 37% in Families Served
  - Highest increase of 107% in CalFresh individuals

- Mandated CWS/Mental Health collaboration-Katie A. lawsuit and Intensive Treatment Foster Care


# Stretched thin...

- Staffing has not kept pace with demand

- Audits and required corrective actions have increased
  - **Backlogs have increased**

### Moving to a 21<sup>st</sup> century model


- Strategic Actions to Compensate for Staffing Shortages and Improve Service to Clients
