## **Summary Text:**


Construction of this project took place on Tepusquet Road, 5.9 miles north of Foxen Canyon Road, in the unincorporated area of the County, east of the City of Santa Maria. It involved realigning and widening an approximately 350-foot section of the roadway. The scope of work consisted of slope excavation, placing of erosion control material on the excavated slopes, roadway excavation and grading, placing base material and paving the road with Hot Mix Asphalt (Type B). The widening and realignment of the road allowed for two uniform 11-foot travel lanes, improved roadway shoulder area, and increased sight distance and improved overall safety and driving conditions in that area.


The Director of Public Works accepted this project as complete on July 2, 2010. The project was completed on time and on budget.

## **Background:**

On May 19, 2009, your Board approved the Categorical Exemption pursuant to the County's California Environmental Quality Act (CEQA) guidelines and authorized the Director of Public Works to advertise the Construction of Road Improvements on Tepusquet Road at Mile Post (MP) 5.9.
