SUBJECT: Kellee Clougherty, M.D., Contract.

Recommendation(s):

That the Board of Supervisors:

- 1. Approve and execute a contract in the amount of \$47,350, with Kellee Clougherty, M.D., not a local vendor, to provide psychiatric services to seriously emotionally disturbed children in the Lompoc and Santa Maria clinics. The contract term is from January 31, 2005 through June 30, 2005.
- 2. Authorize the Director of ADMHS to approve amendments to the proposed contract, provided that any such amendments do not exceed ten percent (10%) of the contract's dollar amount.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work and Visit.

Executive Summary and Discussion:

Dr. Kellee Clougherty will be one of several psychiatrists providing staffing to the Lompoc and Santa Maria Children's Clinics in northern Santa Barbara County. Dr. Clougherty will perform diagnostic, medication, and involuntary admission evaluations, prescribe and administer medication, and provide training, education and support to ADMHS staff and Multi-Disciplinary Team members as needed. Dr. Clougherty will work approximately 20 hours per week, splitting her time between the two North County Clinics.

Your Board is now requested to approve the Kellee Clougherty, M.D., contract in the amount of \$47,350. Approval of this contract will allow ADMHS to provide mandated psychiatric services to severely emotionally disturbed children in the North County.

Outcomes

The contract with Dr. Clougherty will help ADMHS meet **Recurring Performance Measure 0214**, to provide effective mental health care to 2,450 emotionally disturbed children. It is anticipated Dr. Clougherty will perform 10-15 medical evaluations per week over the next 5 months.

Mandates and Service Levels:

Mental Health Services are mandated by the Welfare and Institutions Code, Section 5600.

Fiscal and Facilities Impacts:

The Clougherty contract is funded by Medi-Cal and realignment. These funding sources are identified in the Adopted FY 2004-05, Budget, line items 5404, Medi-Cal; and 4102, realignment funds in the Children's Services Division, County Budget Book, page D-152.

These actions will not result in a need for any additional facilities.
