

FIRST AMENDMENT TO AGREEMENT TO PROVIDE PROFESSIONAL SERVICES

Between
THE SANTA BARBARA COUNTY FIRE DISTRICT
And
DUDEK

This First Amendment to the Agreement to Provide Professional Services (hereafter, "Amendment") is made and entered into by and between the Santa Barbara County Fire District (hereafter, "FIRE") and Dudek, collectively referred to as the "Parties."

RECITALS

WHEREAS, the Parties entered into an Agreement for Services of Independent Contractor dated September 12, 2023 (hereafter, "Agreement") for the project management and the development of the Santa Barbara Foothill Community Wildfire Protection Plan and Transportation Study (hereafter, CWPP); and

WHEREAS, the Agreement was structured with a performance period from September 15, 2023 to June 25, 2025; and

WHEREAS, due to the unforeseen need for additional services and hours to meet project scope, goals and timelines; and

WHEREAS, to ensure completion of the CWPP project, the Parties wish to increase the amount of grant funds allocated to Dudek from \$240,500 to an amount not to exceed \$250,000 without any further modifications to terms and conditions of the existing agreement;

AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the Parties agree to amend the Agreement as follows:

1. Amendment to Compensation of Contractor

The language in EXHIBIT B – PAYMENT ARRANGEMENTS, Periodic Compensation is hereby amended as follows:

Original Language: *For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including reimbursements, not to exceed \$240,500.*

Revised Language: *For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including reimbursements, not to exceed \$250,000.*

2. Designated Representatives

The designated representatives for this Agreement are:

Changes in designated representatives shall be made only after advance written notice to the other Party.

3. Continued Force and Effect

All other terms and conditions of the original Agreement not expressly amended by this Amendment shall remain in full force and effect.






