


Santa Barbara County COVID-19 Data





Santa Barbara County 7-day Average Community Test Positivity Percent





Farmworker Vaccination Pilot

- Goal: Work through the cultural and linguistic barriers faced at vaccination clinics in order to respond to the unique needs of the communities represented
- Partners: CAUSE, MICOP, Herencia Indígena, Ag Commission, and the Growers/Shippers Association
- 496 vaccines given on Sunday 2/28 at the Santa Maria Health Care Center
- Health Education: information on legal, medical, and wellness support/services offered by the county and by partner organizations were provided to each individual. Masks, gloves, and hand sanitizer were also given.
- The majority of staff were bilingual, with 5 interpreters on hand to assist with Spanish and multiple Mixteco dialect translation services for health education, medical consultation, vaccination, and appointment registration

70/30 Vaccine Distribution Plan

- 70% to health care system to serve 65+
 - Hospitals to serve 65+, Tk-12*; higher education
- 30% to Public Health Community Vaccination sites for sectors:
 - Food & Agricultural
 - Childcare
 - Emergency Services



70/30 Vaccine Distribution Plan

➤ Education: TK- 12

- Priority Groups determined by school superintendents
 1. Staff serving students who are unable to wear masks, are medically fragile, or require support that does not allow physical distancing.
 2. Staff with significant contact with others in-person, and/or close proximity to others, and mixing across multiple stable groups and/or locations.
 3. Staff working in-person with direct contact with students or other staff with minimal or no mixing
 4. staff working in-person with limited exposure to other people or working remotely.
- Lompoc Valley Medical Center will vaccinate 1st priority group this week with evening and weekend clinics

➤ Education: High Education

- Will be convening planning group this week with stakeholders in higher education



Vaccine News:

- Johnson & Johnson received EUA on Saturday, 2/27
- Anticipated shipment to CA: at least 380,000 doses
- Unknown allocation to SBC at this time
- Single dose vaccine
- Does not need ultra-cold storage. Can be stored at regular refrigerator temperature.
- Provides strong protection against severe disease and death
- Quicker protection: 2 weeks after shot
- Less serious side effects
- Performs against variants



Outdoors high-contact sports

- With adjusted case rate for SBC below 14 per 100,000: outdoors high-contact sports such as basketball, football, hockey, rugby, rowing, soccer, and water polo can resume.
- Weekly testing will be required for coaches and football, rugby and water polo players who are at least 13 years old. Test results must be available within 24 hours of competition.
- Competitions are permitted only between teams within the same county or from bordering counties where the sport is allowed.
- Required: Face covering & social distancing; sanitation & hygiene; limited audience





Civil Enforcement Options

Civil Complaint/ Injunctive Relief

- County action against businesses
- Support to cities when requested
- Currently exploring actions against egregious offenders

Unfair Competition Law Violation

- DA and City prosecutor (Santa Barbara)
- Fiscal penalties
- Gyms and Fitness Centers (Major Offenders)
 - 1 injunction
 - 1 complied
 - 5 referred



Criminal Enforcement

- Law Enforcement and District Attorney
 - Sheriff and City Law Enforcement
- Violation of HOO
 - \$1,000 penalty
 - Misdemeanor
- Sheriff Criminal Violations issued
 - 7 cases referred to DA (in IV)


