Background

The County organization as a whole, and specific County departments are subject to monitoring by various external entities. The majority of monitoring is performed to ensure State and Federal funds awarded to the County are spent in accordance with applicable regulations and requirements. Instances of non-compliance may result in: 1) the requirement to return funds to the funding agency, 2) reduced funding in future years, and/or 3) increased monitoring costs.

Monitoring can occur at different levels, such as an audit, review, or specific procedures performed on certain processes. Additionally, monitoring periods may vary (i.e. annually, quarterly, on a one-time basis, or randomly).

County policy requires all monitoring performed on departments to be reported to the Office of the Auditor-Controller where the related results are reviewed by the Internal Audit Division. The monitoring results received are included as a component of the annual Countywide Enterprise Risk Assessment and influence the preparation of the annual Internal Audit Plan.

This report presents information from monitoring reports received by County departments and reported to the Auditor-Controller during fiscal year (FY) 2024-25. Any reports presented to the County Board of Supervisors separately, such as the Annual Comprehensive Financial Report and Single Audit Report, are not included in this report. This report also differs from the CEO's Compliance and Accountability Report due to differences in scope, fiscal years presented, and engagement types.

<u>Departments</u> are requested to self-assess a risk rating based upon monitoring results. Internal Audit does not provide any assurance for departmental responses. The risk ratings are as follows:


Low Risk: Potential for low dollar amount of error or loss, other compensating procedures exist, or minimal program impact.


Moderate Risk: Potential for moderate dollar amount of error or loss (relative to the size of the program), some violation of policy, other compensating procedures may exist to correct issue. When a monitoring report indicates that a breakdown in compliance occurred, the risk will be assessed at a minimum of moderate. Nonadherence to policies and procedures, lack of self-monitoring, and a possible future loss of outside funding due to noncompliance will also be assessed at a minimum of moderate.

High Risk: Potential for large dollar amount of error or loss, significant lack of monitoring or breakdown in compliance, or widespread violation of law. Insufficient compensating procedures exist.

Background (Continued)

A listing of all external monitoring reports assessed as low risk (48) are included. There were no external monitoring reports assessed as moderate or high risk this fiscal year. The total number of reports decreased from 71 in the prior year to 48 in the current year, largely due to the concentration of triennial and biennial engagements completed in the prior cycle.
