

**SECOND AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR FOR
BREAKING BARRIERS SUMMER YOUTH EMPOWERMENT AND EMPLOYMENT PROGRAM**

Second Amendment

This is a *Second Amendment* (Second Amendment to the Agreement) to the Agreement for Services of Independent Contractor, by and between the **County of Santa Barbara** (COUNTY) and **Goodwill Industries of Ventura and Santa Barbara Counties** (CONTRACTOR).

WHEREAS, on June 4, 2024, the COUNTY approved the Agreement for Services with CONTRACTOR, BC#23-308, (Agreement) with CONTRACTOR for the provision of Breaking Barriers: Summer Youth Empowerment and Employment Program Service Provider;

WHEREAS, on August 12, 2024, the COUNTY approved the First Amendment with CONTRACTOR to decrease the total contract amount;

WHEREAS, the initial term of the Agreement commenced on May 15, 2024 and is set to expire on September 30, 2024 unless otherwise directed by COUNTY or unless earlier terminated; and

WHEREAS, the parties now desire to amend the Agreement to extend the initial term of the Agreement for six months for the period from May 15, 2024, through March 31, 2025 (Extension Period).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

The Agreement is amended as follows:

1. Section 4, **TERM**, of the Agreement is amended to state in its entirety:

CONTRACTOR shall commence performance on May 15, 2024 and end performance upon completion, but no later than March 31, 2025 unless otherwise directed by COUNTY or unless earlier terminated. The COUNTY at the end of the contract term has an option to renegotiate a no-cost extension up to one (1) additional one (1) year renewal without rebidding with thirty (30) days written notice to the Contractor prior to the expiration of the initial term. A renewal determination will be contingent upon CONTRACTOR's satisfactory achievement of agreed upon performance measures.

2. Section 5, **COMPENSATION OF CONTRACTOR**, of the Agreement is amended to state in its entirety:

In full consideration for CONTRACTOR's services, CONTRACTOR shall be paid for performance under this Agreement in accordance with the terms of EXHIBIT B, including EXHIBIT B-1, *Revised November 2024* for the period of May 15, 2024 through *March 31, 2025 (extension)*, attached hereto and incorporated herein by reference. Billing shall be made by invoice, which shall include the contract number assigned by COUNTY and which is delivered to the address given in Section 2 **NOTICES** above following completion of the increments identified on EXHIBIT B. Unless otherwise specified on EXHIBIT B, payment shall be net thirty (30) days from presentation of invoice.

3. Section A, of **EXHIBIT B, Payment Arrangements**, of the Agreement is amended to state in its entirety:

For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed **\$566,460** for the period of May 15, 2024 through *March 31, 2025*.

In all other respects, the Agreement remains unchanged and shall remain in full effect.
