We are parents of a student at UCSB who currently resides in Isla Vista. Recently we were informed that the county is considering enacting a plan to impose fines on residents of Isla Vista who appear to be violating health guidelines related to COVID-19.

While we are certainly supportive of the guidelines in place, we wanted to voice our STRONG OPPOSITION to this proposed plan. Unless the county intends to enforce this system of fines throughout the entire county, it unfairly targets and penalizes a select group of individuals. There are examples throughout the Santa Barbara community of non-adherence to the current guidelines regarding gatherings and mask wearing, yet there is no plan to impose administrative fines in those situations. Further, there was no suggestion of similar fines over the past few months when students and people of various ages gathered in protest of social issues.

We are a family with a history of public service and supporters of law enforcement. Having said that, both the UCSB and Isla Vista police have a well documented history of unfair and retaliatory actions towards students in Isla Vista. Any policy of this type that would presume to have local police assess and enforce fines would be fraught with confusion and misuse of authority.

If the county has additional resources, those resources would be more productively used to enforce the rampant code, occupancy and landlord violations that have long been a problem in the community. The lack of oversight in this sector contributes to over-crowding and other health violations among the students housed in Isla Vista.
