Title: Increase appropriations and restricted fund balance for Maddy Fund Distribution.

Budget Action: Increase appropriations of \$126,818 in the Public Health Department's Health Care fund for Services and Supplies funded by a release of Restricted PHD Special

Projects fund balance.

Justification: This budget revision will record unanticipated revenues of \$126,818 as Changes to Restricted Fund balance and increase corresponding appropriations by \$126,818 for

Special Department Expense. Maddy legislation SB191, Padilla allows for 15% percent of revenue collected from Fines, Forfeitures and Penalties to be allocated specifically for pediatric trauma centers in the County, known as the Richie's Fund. Maddy distributions from the Richie's Fund will be to the only pediatric trauma center

in the county, Cottage Hospital, for pediatric trauma services and equipment.

The FY 15-16 budget currently has \$71,182 budgeted for pediatric trauma services and equipment. The additional \$126,818 allows for the total distribution amount of

\$198,000 in year 1 as per the budget exhibit of the contract with Cottage Hospital.
