Recommended Actions:

That the Board of Supervisors:

- a) Accept on behalf of the Public, pending recordation of Parcel Map No. 14,806, the offer of dedication for the Easements for Public Utility Purposes as shown on said map, and authorize the Clerk of the Board to endorse the Parcel Map No. 14,806 accepting said Easements as defined on said map. Consummation of the acceptance of the Easements for Public Utility Purposes is subject to recordation of the subject Map; and
- b) Determine that an action by the Board to accept said offers of dedication is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15315 of the Guideline of Implementation of the CEQA. The map was conditioned to offer said easements, therefore, the Board's action to accept the subject easement is similarly determined to be exempt from the CEQA.

Summary Text:

This item is on the agenda in order to accept easements for Public Utility purposes offered on Parcel Map No. 14,806. The County Surveyor's Office has reviewed Parcel Map No. 14,806 (County Assessor Parcel Number 061-170-001), located at 4575 Auhay Drive, in the Goleta area, Second Supervisorial District.

Prior to the Clerk of the Board's endorsement on the subject Parcel Map accepting the Easements for Public Utility Purposes, the County Surveyor will be satisfied that said Map is technically correct, conforms to the approved Tentative Map (or any approved alterations thereto), and complies with all applicable laws and regulations.

After the map has been found to be technically correct and all departments and utilities concerned with the processing of Subdivision Maps have certified that the map is ready for recordation, and the payment of Real Property Taxes have been made or bonded for and deposited with the Clerk of the Board, the County Surveyor will present the Parcel Map to the Clerk for endorsement.

After the Clerk endorses its acceptance of said Easements for Public Utility Purposes thereon, the County Surveyor will deliver the Parcel Map to the County Recorder for recordation.

Background:

At its regularly scheduled meeting on August 11, 2014, the Santa Barbara County Zoning Administrator met and approved Parcel Map No. 14,806 which was exempt from the CEQA for the subject project. The Project, which included granting the subject easements to the County, was found exempt from environmental review pursuant to Section 15315 of the Guidelines for Implementation of the CEQA. This section provides an exemption for the division of property in urbanized areas zoned for residential, commercial, or industrial use into four or fewer parcels when the division is in conformance with the General Plan and Zoning, no variances or exceptions are required, all services and access to the proposed parcel to local standards area available, the parcel was not involved in a division of a large parcel within the previous 2 year and the parcel's average slope is less than 20 percent.

After the County Surveyor is satisfied that all of the conditions of approval for Parcel Map No. 14,806 have been met and the payment of Real Property Taxes have been made or bonded for, he shall present the Map to the Clerk of the Board and request acknowledgement of the Board's acceptance of said Easements for Public Utility Purposes thereon. Once the Map has been endorsed by the Clerk, the County Surveyor shall transmit it to the County Recorder's Office for recordation.
