

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE

WHEREAS, California Vehicle Code Sections 22507 and 22651(n) and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County, to establish parking regulations on portions of roads and highways under its jurisdiction as “No Parking-Tow Away” zones by resolution; and

WHEREAS, it is in the best interest of public safety that certain portions of County highways near the Hot Springs Trailhead be designated as no stopping, standing, or parking tow away zones, in accordance with said Sections; and

WHEREAS, the parking of vehicles on these sections of the County highways, on the shoulder, or during certain times may potentially compromise public safety in the event of a fire emergency; and

THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated no stopping, standing, or parking tow away zones, as follows:

No Parking, Stopping, or Standing Tow Away Zone

- On the north side of East Mountain Drive from the centerline of Hot Springs Road to a point 275 feet west of the centerline of Hot Springs Road.
- On the north side of East Mountain Drive from a point 325 feet west of the centerline of Hot Springs Road to a point 700 feet west of the centerline of Hot Springs Road.
- On the north side of East Mountain Drive from a point 380 feet west of the centerline of Hot Springs Road to a point 550 feet west of the centerline of Hot Springs Road.
- On the south side of East Mountain Drive from a point 340 feet east of the centerline of Riven Rock Road to a point 450 feet east of the centerline of Riven Rock Road.
- On the south side of East Mountain Drive from the centerline of Riven Rock Road to a point 270 feet west of the centerline of Riven Rock Road.
- On the north side of East Mountain Drive from the centerline of Riven Rock Road to a point 340 feet west of the centerline of Ashley Road.
- On the south side of East Mountain Drive from the centerline of Ashley Road to a point 190 feet west of the centerline of Ashley Road.
- On the east side of Riven Rock Road from the centerline of East Mountain Drive to a point 800 feet south of the centerline of East Mountain Drive.

No Parking Sunset to 8:00 A.M. Tow Away Zone

- On the north side of East Mountain Drive from a point 275 feet west of the centerline of Hot Springs Road to a point 325 feet west of the centerline of Hot Springs Road.
- On the north side of East Mountain Drive from a point 550 feet west of the centerline of Hot Springs Road to a point 595 feet west of the centerline of Hot Springs Road.
- On the south side of East Mountain Drive from a point 270 feet east of the centerline of Riven Rock Road to a point 330 feet east of the centerline of Riven Rock Road.
- On the south side of East Mountain Drive from a point 285 feet east of the centerline of Riven Rock Road to a point 340 feet east of the centerline of Riven Rock Road.
- On the west side Riven Rock Road from the centerline of East Mountain Drive to 2,400 feet south of the centerline of East Mountain Drive.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to remove, add, and/or amend appropriate markings and/or signs at said locations as time and resources permit.


