DA - Increase Appropriations for E-SCARS Grant

Budget Action: Increase appropriations in the amount of \$300,000 in the District Attorney's Office General Fund for Salaries and Employee Benefits (\$158,428), Services and Supplies (\$26,572), and Capital Assets (\$115,000) funded by unanticipated grant revenue from the California Office of Emergency Services (Cal OES) for the Electronic

Suspected Child Abuse Reporting System (E-SCARS) program.

Justification:

Suspected Child Abuse Reports are currently manually cross-reported via fax transmission. In an effort to close the gaps caused by the current manual system, the District Attorney applied for and was awarded grant funding from Cal OES for the development and implementation of an Electronic Suspected Child Abuse Reporting System (E-SCARS). E-SCARS will be a secure, web-based application used to report, investigate, and electronically track allegations of child abuse, neglect, or endangerment in Santa Barbara County. It will enable the electronic transmission and receipt of reports across agencies, allow robust audit functions to ensure accountability, and facilitate oversight functions through improved tracking.

The grant award is \$300,000 for the current grant period of 1/1/2017 - 12/31/2018. There is no required in-kind match. The current budget includes \$26,572 in operating costs, \$115,000 in capital equipment costs, and \$158,428 in Salaries and Employee Benefits costs. Salary and Employee Benefit costs are comprised of \$113,612 for one new 1.0 FTE EDP Systems and Programming Analyst dedicated to the E-SCARS program, as well as \$44,816 in salaries and benefits for existing DA positions that will be involved in the program. An additional \$450,000 has been awarded through June 30, 2021. This will bring the total grant award for this project to \$750,000 for the period of 1/1/2017 - 6/30/2121. These additional award allocations will be included in future recommended budgets.
