The Santa Barbara County Veteran's Collaborative, the 100 day Veteran's Housing Challenge, the WWII Project and the Stories of Honor were all successful because of the time and love Kathy poured into these projects and;

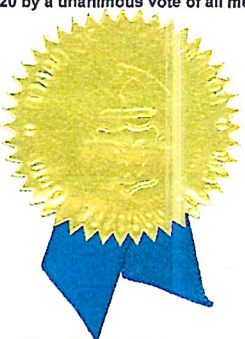
