Sheriff: Recognize \$21,580 in donation revenue from the Douglas Foundation to purchase a van to be used by the Explorer Program, sponsored by the Sheriff's Department.

The Sheriff's Department has received a \$21,579.09 donation from the Douglas Foundation to pay for a van to be used by the Explorer posts sponsored by the Sheriff. The donation will be accounted for as revenue to the Sheriff's Department and an increase in fixed assets for the purchase of the vehicle. The donation covers the full purchase price of the van . The Sheriff's Department anticipates that the van will cost about \$1,500 per year to operate and this will be covered by Explorer post funding. The Explorer program is fully funded by donation revenue.
