## **Summary:**

During the agenda review process in advance of the October 28, 2008 Board of Supervisors meeting, it was determined that a limited number of regularly scheduled meetings of the Board of Supervisors remain during 2008 (November 4, November 18 and December 9, 2008). Due to concern over the amount of scheduled hearing time remaining in 2008, the concept of adding an additional meeting was discussed. After consulting with Board Chair Salud Carbajal, it was determined appropriate to consider adding a meeting for December 16, 2008 in order to accommodate matters anticipated to come before the Board in November and December. Should this request be approved, all County departments will be advised of the amendment to the meeting schedule. As such, staff is recommending that the Board add a regular meeting of the Board of Supervisors for Tuesday, December 16, 2008 in Santa Maria.

In addition, to accommodate matters related to South Coast projects anticipated to come before the Board in December (including the appeal of the Miramar Hotel Project), staff is recommending that the meeting of December 9, 2008 be rescheduled to Santa Barbara.
