

## **FIRST AMENDMENT TO AGREEMENT TO PROVIDE PROFESSIONAL SERVICES**

**Between**  
**THE SANTA BARBARA COUNTY FIRE DISTRICT**  
**And**  
**MISSION CRITICAL PARTNERS, LLC**

This First Amendment to the Agreement to Provide Professional Services (hereafter, "Amendment") is made and entered into by and between the Santa Barbara County Fire District (hereafter, "FIRE") and Mission Critical Partners, LLC (hereafter, "MCP"), collectively referred to as the "Parties."

### **RECITALS**

WHEREAS, the Parties entered into an Agreement for Services of Independent Contractor dated August 19, 2024 (hereafter, "Agreement") for the planning and implementation of public safety communications under a new operational platform, utilizing updated technology and equipment to enhance emergency response capabilities;

WHEREAS, the Agreement was originally structured with a go-live date of January 2025 for the Regional Fire Communications Center (RFCC);

WHEREAS, due to unforeseen delays in the RFCC go-live timeline, the anticipated implementation date has been revised to May 2025, with the possibility of further schedule adjustments;

WHEREAS, to ensure continuity of service and avoid disruption to project implementation, the Parties wish to extend the term of the Agreement under the same terms and conditions without modification;

### **AGREEMENT**

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the Parties agree to amend the Agreement as follows:

1. Amendment to Term

The language in Section 4 – Term of the Agreement for Services of Independent Contractor is hereby amended as follows:

Original Language: *CONTRACTOR commenced performance on May 29, 2024, and shall end performance upon completion, but no later than February 28, 2025, unless otherwise directed by COUNTY or unless earlier terminated.*

Revised Language: *CONTRACTOR commenced performance on May 29, 2024, and shall end performance upon completion, but no later than December 31, 2025, unless otherwise directed by COUNTY or unless earlier terminated.*

2. Designated Representatives

The designated representatives for this Agreement are:

For FIRE: Mark Hartwig, Fire Chief, Santa Barbara County Fire District, 4410 Cathedral Oaks Rd, Santa Barbara, CA 93465

For MCP: Darrin Reilly, President and CEO, Mission Critical Partners, LLC, 690 Grays Wood Blvd, Suite 100, Port Matilda, PA 16870

Changes in designated representatives shall be made only after advance written notice to the other Party.

3. Continued Force and Effect

All other terms and conditions of the original Agreement not expressly amended by this Amendment shall remain in full force and effect.




