#### 340B CONTRACT PHARMACY SERVICES AGREEMENT

# between SANTA BARBARA COUNTY and WALGREEN CO

#### FIRST AMENDMENT

**THIS FIRST AMENDMENT** (hereafter referred to as **First Amendment**) to the 340B Contract Pharmacy Services Agreement, is entered into by and between the County of Santa Barbara, an organization approved by the State Department of Health Care Services as a Federally Qualified Health Center (hereinafter referred to as "County"), and the Walgreen Co, dba Walgreens.

- 1. <u>Definitions.</u> Capitalized terms used in this First Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.
- 2. Amendments.
- a. **EXHIBIT B,** to the Agreement is deleted in its entirety and replaced with the attached Exhibit B, which is attached hereto and incorporated herein by reference.
- 3. Ratifications. The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, as expressly modified and superseded by this First Amendment, are ratified and confirmed and shall continue in full force and effect as legal, valid, binding and enforceable obligations of the parties.
- 4. <u>Counterparts.</u> This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
