**AMENDMENT NO. 1 TO
AGREEMENT FOR PROFESSIONAL LEGAL SERVICES BETWEEN
THE COUNTY OF SANTA BARBARA AND
STRADLING YOCCA CARLSON & RAUTH,
A PROFESSIONAL CORPORATION**

This **AMENDMENT NO. 1** to the Agreement for Professional Legal Services between the County of Santa Barbara (COUNTY) and Stradling Yocca Carlson & Rauth, a Professional Corporation (ATTORNEY) with an effective date of September 25, 2023 (Agreement) is hereby entered into by and between COUNTY and ATTORNEY.

WHEREAS, COUNTY and ATTORNEY entered into an Agreement for disclosure counsel services in connection with the proposed 2024 Certificates of Participation financing; and

WHEREAS, the financing has taken more time than initially expected by the parties, and is requiring additional work by ATTORNEY, and the parties now wish to increase the amount of the Agreement by \$7,500 to compensate ATTORNEY for such additional work;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, COUNTY and ATTORNEY hereby amend the Agreement as follows:

A. In Exhibit B, Payment Arrangements, Section A is replaced with the following:

For ATTORNEY services to be rendered under this Agreement, ATTORNEY shall be paid a total contract amount, including cost reimbursements, not to exceed \$57,500. Payment of fees and costs is contingent on the issuance and closing of the COPs.

B. In Attachment B-1 (Schedule of Fees), the sentence "Amounts charged to this Agreement shall not exceed \$50,000." is replaced by the following sentence: "Amounts charged to this Agreement shall not exceed \$57,500."

Except as provided herein, said Agreement shall continue in full force and effect.
