That the Board of Supervisors:

- a) Accept Notice of Completion for work performed by Union Asphalt Inc., (A Local Vendor), P.O. Box 1280; Santa Maria, California 93456 and authorize Clerk to record.
- b) Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor in the amount of \$1,108,110.50.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No.1: An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

Due to necessary updating and on going wear and tear, this work was proposed by the Airport Authority in order to properly maintain the airport. The work required included Apron Rehabilitation, Access Road Reconstruction, Infield Drainage Improvements, and Airfield Slurry Seal. Activities included the removal

and reconstruction of existing asphalt pavement surfaces, pavement pulverizing, subgrade preparation, installation of aggregate base and asphalt pavement, construction of concrete valley gutters, installation of storm drainage, modifications to existing storm drain inlets and outlets, installation of aircraft tie-downs, and installation of pavement markings.

The Board contract to Union Asphalt Inc. was awarded on September 13, 2005. Construction of the apron rehabilitation, access road reconstruction, and airfield slurry seal project started on October 3, 2005 and ended on April 28, 2006. The project has been inspected and accepted completed by the Resident Engineer, Chairman of the Santa Ynez Valley Airport Authority and County Airport Manager. There were two (2) contract amendments.

On April 18, 2006 the Board of Supervisors authorized the execution of Contract Amendment No. 1 in the amount of \$80,495.28. The Federal Aviation Administration approved the Construction Change Authorizations associated with Contract Amendment No. 1 on March 28, 2006.

On July 25, 2006 the Board of Supervisors authorized the execution of Contract Amendment No. 2 in the amount of \$28,275.62. The Federal Aviation Administration approved the Construction Change Authorizations associated with Contract Amendment No. 2 on July 6, 2006.

The Contractors Bid Amount was \$999,339.60. The final adjusted cost for the extra work, Contract Amendments No. 1 & No. 2 is \$108,770.90. The total cost of the Apron Rehabilitation Project (Union Asphalt, Inc) is \$1,108,110.50.

Mandates and Service Levels:

Direction by the Board of Supervisors will not change the programs or service levels. The County is under no mandate to apply for and receive grants to perform the improvements, however as landowners, only the County is eligible to do so. The County manages the grant and subsequent construction on behalf of the Airport Authority, as it retains responsibility for compliant execution.

Fiscal and Facilities Impacts:

Funding for this project is provided by three separate grants from the Federal Aviation Administration (FAA), State matches from the California Department of Transportation, Aeronautics Program and a small local match from the Santa Ynez Airport Authority. Ninety-five percent (95%) is funded by the FAA. The State of California-Department of Transportation-Aeronautics Program State Matching Grant is 4.8%. The Santa Ynez Valley Airport Authority is paying the local share of 0.2%. The Santa Ynez Valley Airport Authority will be covering the State's share of federal Airport Improvement Program (AIP) grant 3-06-0243-09.
