Goller for a permanent non-excusive ten (10) feet wide easement for the purposes of public riding and hiking trail which affects Assessor Parcel Numbers 149-290-001 and -004, by authorizing the Clerk of the Board to sign the Certificate of Acceptance attached thereto.

<u>Summary Text:</u> The County Parks Department wishes to acquire this easement across the Goller property to extend a new foot bridge in Richardson County Park, and establish a trail for the students of Cuyama High School which crosses the southerly part of the property.

## **Background:**

The Goller property is located on the south side of State Highway 166 West of Cuyama High School and East of New Cuyama. In the past this property has been used for access to Cuyama High School by students crossing to the High School from Richardson County Park, which is County owned. The Goller property is a 37.88 acre parcel of land. The property is vacant unimproved land.
