#### **Recommended Actions:**

That the Board of Supervisors:

- A. Approve and authorize the Chair to execute the attached Agreement for Services of Independent Contractor with Family Service Agency (FSA) to provide group counseling to probation youth, through funding from SB163, in the Santa Barbara and Lompoc geographic areas for Fiscal Year (FY) 2015-2016, with a total contract amount not to exceed \$36,492.00 (the "Agreement") (Attachment A); and
- B. Determine that the approval of the Agreement is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3), finding that this activity is covered by the general rule that CEQA applies to projects which have the potential for causing a significant effect on the environment, and where it can be seen with certainty that there is no possibility that this activity may have significant effect on the environment, the activity is not subject to CEQA, and direct staff to file a Notice of Exemption (Attachment B).

## **Summary Text:**

The program is being supported by SB 163 Wraparound reserve funding with the objective of mitigating the likelihood of out-of-home removal for female wards of the Juvenile Court, as well as reducing the

prevalence of high-risk behavior among other females supervised by the Probation Department. The program will serve female juvenile offenders and at-risk females referred by the Probation Department.

#### **Background:**

SB 163 was passed by the State Legislature in 2003 with the intent to provide children with service alternatives to group home care through the development of expanded family-based services programs. These programs include individualized or "wrap-around" services. The services developed were to build on the strengths of each eligible child and family and be tailored to address their unique and changing needs.

The legislation encourages collaboration among entities including, county welfare, mental health, health and probation departments and private service providers for the purpose of providing services for children. It also encouraged the use of the expertise of nonprofit providers to develop family-based and community-based service alternatives.

In Santa Barbara County, the funding received through SB163 is utilized to fund contracts for "wrap-around" services administered through the Department of Social Services. In addition, the Probation Department has a portion of funding set aside to provide female-specific group counseling to those female wards deemed to be at high risk due to their behavior with the objective of mitigating the likelihood of out-of-home removal as well as reducing the prevalence of high-risk behavior among other females supervised by the Probation.

#### **Performance Measure:**

- A. FSA staff will facilitate a total of eight (8) separate counseling groups; 80 total group sessions; 160 total hours; up to 80 total participants.
- B. FSA will contact each referred youth within five (5) business days from receipt of the referral.
