Approve the attached Resolution in support of the County's application for funding from the Caltrans Bicycle Transportation Account (BTA).

Summary Text:

The Department of Public Works is seeking Board approval of a Resolution supporting a project in the Orcutt area for which funding from the BTA grant program is sought. The project is a proposed bicycle and pedestrian bridge in the community of Orcutt. The bridge will span Orcutt Creek located on a newly acquired County open space referred to as "Key Site #8" in the Board's adopted Orcutt Community Plan. The open space contains an important Class I bikeway linking neighborhoods south of Clark Avenue and west of Highway 101. This Class I bikeway ends at the banks of Orcutt Creek and the bridge is required to provide a safe, convenient and all-weather access to this bikeway.

Background:

Caltrans issues an annual call for projects under the State's BTA. Each year, eligible jurisdictions may apply in a competitive process for approximately \$7 million in available state-wide funding. The BTA program will pay for up to 90% of the cost of the project with local jurisdictions funding the remaining

10%. If the County receives an award of funding, the County's Transportation Development Act Bicycle/Pedestrian Account would provide the necessary matching funds to complete the project.

The County recently completed the reconstruction of the Goleta Beach Bikeway utilizing a BTA grant award of \$108,000 received in 2008. Matching funds from the County's Transportation Development Act Bicycle/Pedestrian account totaling \$12,000 were used to complete the project.
