Recommended Actions:

That the Board of Supervisors:

- a) Approve and authorize the Director of the Department of Behavioral Wellness or designee to execute a Memorandum of Understanding (MOU) with the California Department of State Hospitals and the California Mental Health Services Authority (CalMHSA) for County use of State hospital beds for the period of July 1, 2025 through June 30, 2027;
- b) Approve, ratify, and authorize the Chair to execute a First Amendment to the State Hospital Beds Program Participation Agreement with CalMHSA (No. 4640-SHB-2023-SB) to extend the term of the contract from June 30, 2025, through June 30, 2026, for a revised contract term of July 1, 2023 through June 30, 2026, and increase the total maximum amount payable under the contract by \$11,216 for a revised contract maximum not to exceed \$36,452 (inclusive of \$12,618 per fiscal year [FY] for FY 2023-25 and \$11,216 for FY 2025-26); and
- c) Determine that the above-recommended actions are not a project that is subject to environmental review under the California Environmental Quality Act (CEQA), pursuant to

CEQA Guidelines section 15378(b)(4) and (b)(5), finding that the actions are administrative activities of government and governmental funding mechanisms and/or fiscal activities that will not result in direct or indirect physical changes in the environment.

Summary Text:

These items are on the agenda to request that the Board of Supervisors approve, ratify, and authorize the Director of Behavioral Wellness (BWell) or designee to enter into a Memorandum of Understanding (MOU) with CalMHSA and the Department of State Hospitals (DSH) for FY 2025-27, regarding use of State hospital beds, and to execute the CalMHSA State Hospitals Program Participation Agreement (PA) FY 2023-25 First Amendment to now amend and extend the PA through June 30, 2026 and to increase the administrative fee by \$11,216 for FY 2025-26, for a new contract maximum not to exceed \$36,452.

Background:

On April 1, 2014, the Board of Supervisors authorized BWell to become a member of CalMHSA. CalMHSA, the administrative agent for behavioral health departments, negotiates the State Hospital Bed MOU with DSH on behalf of city and county mental health authorities. Section 4330 of the California Welfare and Institutions Code requires counties to reimburse DSH for the use of state hospital beds and services by their residents. Clients referred to State hospitals by BWell are individuals who have mental illnesses requiring continuity of care and inpatient services or individuals who, under the Lanterman Petris Short Act "Murphy" Conservatorships, were previously found incompetent to stand trial on specific felony charges.

On May 20, 2014, the Board of Supervisors approved BWell's entrance into the first State Hospital Bed MOU between CalMHSA and DSH and the Board of Supervisors subsequently approved amendments to extend the date of the MOU through June 30, 2021. As a member of CalMHSA, participating counties, including the County of Santa Barbara, are able to sign on to the negotiated agreement between CalMHSA and DSH for the County's State hospital bed needs. The MOU provided BWell with consistently low rates.

On February 1, 2022, the Board of Supervisors approved the CalMHSA and DSH State Hospital Beds (SHB) MOU from July 1, 2021, through June 30, 2022. On November 1, 2022, the Board of Supervisors approved the First Amendment to that agreement, which revived the CalMHSA and DSH MOU FY 2021-22 and extended the term through December 31, 2022. The short-term Amendment allowed CalMHSA and DSH to continue negotiating the FY 2022-23 MOU and update the bed rate for the purchase of State hospital beds. The bed rate increased for the first time in eight years. However, CalMHSA was able to obtain the lowest possible rate with the DSH (\$1,402 per bed). On May 7, 2024, the Board of Supervisors approved the FY 2023-25 MOU and FY 2023-25 PA No. 4640-SHB-2023-SB with CalMHSA and the County.

On April 18, 2025, CalMHSA sent the FY 2025-27 MOU to the County. CalMHSA is extending the PA that allows for the payment of the administrative fee to CalMHSA by counties for the administration of the SHB programs. Based on June 2023 data provided by DSH, Santa Barbara County is currently allocated an annual bed number of nine beds, and FY 2025-26's allocated bed number is eight beds. Actual State hospital bed usage and client placement levels can vary (see chart below). BWell's bed utilization estimate is based on County's historical use of State hospital beds. The PA with CalMHSA is inclusive of administrative fees, for the period of July 1, 2023, through June 30, 2025 for a contract maximum of \$25,236 (inclusive of \$12,618 for each FY 2023-24 and FY 2024-25). This amendment extends this PA to a 36-month term of July 1, 2023 through June 30, 2026 with an increase of \$11,216, for a revised agreement amount of \$36,452.

The contract with CalMHSA covers the administrative fee associated with serving as an intermediary between the County and the Department of State Hospitals to negotiate rates on behalf of multiple counties. This fee is separate from the actual cost of State Hospital beds.

Behavioral Wellness will utilize Behavioral Health Realignment (State) funds to cover both the cost of State Hospital beds and the CalMHSA administrative fee. This funding source has been included in the FY 2025–26 Recommended Budget.

Historically, annual State Hospital bed costs have ranged from \$2.6 million to \$2.9 million over the past two years. For FY 2024–25, slightly lower utilization is projected, with estimated costs of approximately \$2.5 million.
