Recommended Actions:

- 1. Approve a resolution designating certain county officials as being authorized to seek financial assistance under the Emergency Management Performance Grant;
- 2. Authorize the Santa Barbara County Office of Emergency Services (OES) to apply for the 2007 Emergency Management Performance Grant (EMPG) Program in the amount of \$97,296, which provides funding for emergency management planning.

Summary Text:

The resolution authorizes certain county officials to take the actions necessary for the purpose of obtaining financial assistance provided by the federal Department of Homeland Security and subgranted through the State of California for the FY 2007 Emergency Management Performance Grant (EMPG). The Governor's Office of Emergency Services administers the EMPG Program and has allocated \$97,296 for the Santa Barbara Operational Area for the 2007 federal fiscal year. It is requested that the Board authorize OES to apply for the FFY 2007 Emergency Management Performance Grant (EMPG) in the amount of \$97,296. The funding provides for personnel expenses for authorized emergency planning staff, indirect costs, and some services and supplies. The grant requires a 100% match, which can be accomplished by offsetting existing personnel costs.

Background:

The EMPG program is administered by OES and supports emergency management through all-hazards planning. The EMPG allows OES to enhance existing planning, preparedness, response and recovery efforts through coordination with other local, state and federal agencies, private, non-profits, and tribal entities. The FY 2007 EMPG supports emergency management and enhances mitigation, preparedness, response and recovery capabilities for all hazards. EMPG funds will be used to support activities that contribute to enhance these capabilities.

These funds may also be used to provide equipment or supplies to enhance emergency management throughout the Operational Area. The amount allocated by the State for FY 2007 is \$97,296. The FY 2007 EMPG term extends through September 30, 2007.
