

Name Change

Staff is proposing to rename the program:

- ➤ Previously known as "Coastal Resources Enhancement Fund" or "CREF"
- ➤ New name proposed is "Coastal Resources Mitigation Fund" or "CRMF"



Reassessment of CRMF Fees

- 1 5 points in each impact category
 - Coastal Aesthetics
 - Coastal Recreation
 - Coastal Tourism
 - Environmentally Sensitive Coastal Resources

- Points multiplied by fixed dollar amount
 - \$20,000 in 1988 and adjusted by CPI
 - \$53,100 in 2022 dollars

- ➤ Summarizes status of the 330 CREF grants since 1988
- ➤ CRMF grants are organized by district
- ➤ Organized by category (acquisitions, capital improvements, P&R, educational and equipment)

CRMF Guidelines Amendments

- > Amend the CRMF Guidelines to reflect the name change
- ➤ Update tables in the CRMF Guidelines to reflect the 2023-2027 reassessment
- Document the CRMF funds set aside for the HRAP

Recommended Actions

- a) Change the name and acronym for the "Coastal Resources Enhancement Fund" ("CREF") to "Coastal Resources Mitigation Fund" ("CRMF");
- b) Reassess oil and gas project CRMF payments for 2023-2027
- c) Receive and file the annual CRMF Status Report;
- d) Direct staff to set aside \$124,999 from both the 2022 and 2023 CRMF fees (total of \$249,998) for the Hollister Ranch Access Program (HRAP);
- e) Direct staff to divide the remaining CRMF fees for each year equally between the general allocation subfund and the coastal acquisition subfund;
- f) Amend the CRMF Guidelines to document the above-mentioned;
- g) Direct staff to commence a combined two-year 2022-2023 CRMF cycle; and
- h) Determine that changing CRMF's name/acronym, reassessing the fees, receiving the annual Status Report, allocating 2022 and 2023 annual fees, and updating the CRMF Guidelines are exempt from CEQA
