Title: Gun Violence Reduction Program Grant

Budget Action: Increase Appropriations of \$539,660 in Sheriff General Fund to increase Restricted Sheriff Categorical Grants Fund Balance (\$401,698); Salaries and Benefits (\$123,462) and Services and Supplies (\$14,500) funded by Unanticipated Revenue from Intergovernmental Revenue-State.

Justification:

The Santa Barbara County Sheriff's Office has been awarded a grant of \$539,660.00 from California Department of Justice (DOJ) to allow for effective enforcement of firearms laws prohibited certain individuals from possessing firearms and ammunition. This grant will be used to implement an Armed Prohibited Persons team and will assigned one dedicated full-time detective. The detective will investigate potential violations by analyzing the Armed Prohibited Person System (APPS) list. The detective will work diligently combing through the APPS list to identify persons living within the cities and unincorporated areas of the County of Santa Barbara, who are prohibited from owning firearms.
