Approve the attached contract providing law enforcement services to the City of Goleta by the Sheriff's Office for the period from July 1, 2012 through June 30, 2017.

Summary Text:

The Sheriff's Office has provided a full range of contract law enforcement services to the City of Goleta since the incorporation occurred in 2002 (Board Agenda items # 02-00579 and #07-00988). The most recent contract spanned five years and was concluded on June 30, 2012. In anticipation of the expiration of the contract, discussions regarding the contract were conducted by city staff, council members and Sheriff's Office representatives. This present contract provides for continuing law enforcement services to the City of Goleta by the Sheriff's Office from July 2012 through June of 2017.

Background:

The value of the contract with the City of Goleta for the FY2012-13 is \$7,087,824 plus actual operational costs for motorcycle units and actual overtime incurred. Categories of expense reimbursed are listed in Exhibit B of the contract. Department-applied overhead is charged on a pro-rata basis but county-wide overhead is not included per Government Code section 51350. The contract stipulates that the cost of the contract will be recalculated each fiscal year to account for changes in staffing costs and other services. The contract also allows for changes in service level at the written request of the City and acceptance by the County.
