Title: Increase CenCal revenue and grant funding for Capital Asset specimen extractor.

Budget Action: Increase appropriation of \$42,500 in Health Care Public Health for Capital Assets funded by unanticipated revenue from CenCal (\$28,500) and transfer of appropriation

from Services and Supplies (\$14,000) for purchase of a specimen extractor.

Justification: This budget revision is necessary to establish a capital asset appropriation for a higher volume more efficient specimen extractor in the Public Health Laboratory for

Influenza, Norovirus and Pertussis testing. Funding, in the amount of \$14,000, is available in the Public Health Emergency Preparedness grant and through

unanticipated revenue from CenCal due to higher than anticipated volume of new Medi-Cal expansion members. This capital asset will replace a low-volume extractor.
