WHEREAS, the County of Santa Barbara (COUNTY) and MEDINA SYSTEMS CONTRACTING, INC. (CONTRACTOR), 1219 Flynn Road, Unit 204, Camarillo, CA 93012 entered into a contract agreement dated August 9, 2011 (AGREEMENT), for the amount of FOUR HUNDRED EIGHTY SIX THOUSAND EIGHT HUNDRED DOLLARS AND ZERO CENTS (\$486,800.00) for the updating and upgrading of the electronic security systems at the Main Jail campus, General Services Project Number 8519, Santa Barbara California; and

WHEREAS, the County of Santa Barbara amended this contract on May 14, 2013. This amendment increased the contract to not exceed the amount of SIX HUNDRED SEVENTY THOUSAND FOUR HUNDRED FORTY TWO DOLLARS AND FORTY TWO CENTS (\$670,442.42) with work to be completed by June 28, 2013; and

WHEREAS, it has been deemed necessary by the Sheriff's Office to alter the cumulative amount totaling ONE THOUSAND FIVE HUNDRED AND NO CENTS to cover unforeseen project close-out costs.

NOW, THEREFORE, the AGREEMENT is amended to increase the cumulative amount by ONE THOUSAND FIVE HUNDRED AND NO CENTS as follows:

Section One:

Paragraph 5 of said Contract is hereby amended to read as follows:

"As full compensation for furnishing all labor, supervision, overhead, materials and equipment and for doing all the work completed and embraced in this AGREEMENT and subject to adjustments and liquidated damages, if any, as provided in the Contract Documents, the base amount to be paid to the CONTRACTOR for satisfactory completion of all requirements of the Contractor under this AGREEMENT is and shall not exceed SIX HUNDRED SEVENTY ONE THOUSAND NINE HUNDRED FORTY TWO DOLLARS AND FORTY TWO CENTS (\$671,942.42), to be paid as provided in the Contract Documents dated August 9, 2011."

The balance of the paragraph remains unchanged.

Paragraph 11 is said Contract is hereby amended as follows:

"The work to be done under this Agreement shall be completed by December 31, 2013 upon execution of this Agreement."

The balance of the paragraph remains unchanged.

Section Three:

This Contract Amendment, along with the consent of the CONTRACTOR attached hereto, shall constitute a contract between the County of Santa Barbara and Medina Systems Contracting, Inc. All other sections of the Agreement between the parties shall remain in full force and effect.
