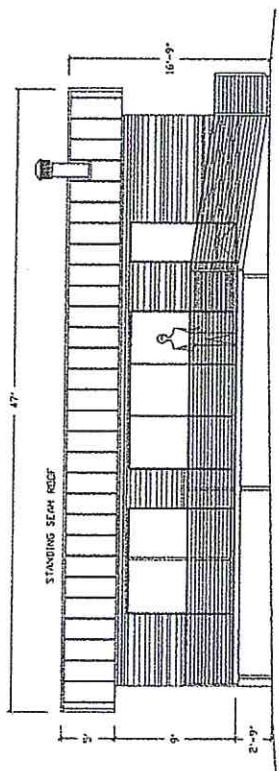
WEST ELEVATION

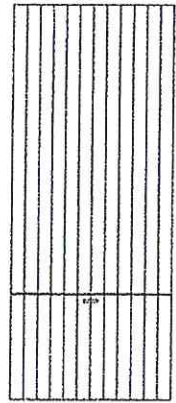
INTERIOR COURTYARD NORTH ELEVATION
