TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This First Amendment (hereafter First Amended Contract) to the Agreement for Services of Independent Contractor, <u>BC 18215</u>, is made by and between the **County of Santa Barbara** (County) and **Santa Ynez Valley People Helping People** (Contractor), for the payment for services performed at the County's request and inadvertently omitted from the Contractor's Agreement, as specified herein.

Whereas, Contractor represents that it is specially trained, skilled, experienced, and competent to perform the special services required by County and County desires to retain the services of Contractor pursuant to the terms, covenants, and conditions referenced herein;

Whereas, at the request of County, Contractor provides Community Coalitions/Tasks Forces program services that enhance state and local alcohol and drug prevention efforts by mobilizing communities, participating in policy advocacy, and changing social norms.

Whereas, Contractor provided, at the request of County, a greater number of services than contemplated by the original Agreement, and incurred expenses beyond the value of the Agreement. So as to compensate Contractor for the additional services rendered under the Agreement, this First Amendment adds Alcohol and Drug Program funds for Fiscal Year 17-18 in the amount of \$10,250, for a new Total Contract Maximum of \$151,250 through June 30, 2018.

Whereas, this First Amended Contract incorporates the terms and conditions set forth in the Agreement approved by the County Board of Supervisors in September 2017, except as modified by this First Amended Contract.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, County and Contractor agree as follows:

- I. Delete Section II. of Exhibit B-ADP, and replace with the following:
 - II. MAXIMUM CONTRACT AMOUNT. The Maximum Contract Amount shall not exceed \$151,250, inclusive of \$100,250 in Alcohol and Drug Program Funding, and shall consist of County, State, and/or Federal funds as shown in Exhibit B-1 ADP. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Contract Amount for Contractor's performance hereunder without a properly executed amendment.
 - II. Delete Section II. of Exhibit B-MH, and replace with the following:
 - **II. MAXIMUM CONTRACT AMOUNT.**

The Maximum Contract Amount of this Agreement shall not exceed \$151,250, inclusive of \$51,000 in Mental Health funding, and shall consist of County, State, and/or Federal funds as shown in Exhibit B-1 MH and subject to the provisions of Section I. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Contract Amount for Contractor's performance hereunder without a properly executed amendment.

III. Delete Exhibit B-1-ADP, Schedule of Rates, and replace with the following:
