RE: Response to Water Supplies and Drought Activities Information Request

Dear Chairman Lavagnino,

In response to your letter dated May 12, 2014, regarding the drought conditions in the City of Lompoc, I am happy to supply the following information. For over 15 years the City of Lompoc has engaged in a comprehensive water conservation program for Lompoc residents and businesses. In the last 15 years, the City of Lompoc has spent \$1,118,284.54 on water conservation programs. The City's successful programs have reduced per capita consumption by 35% and at 103 gallons per person, per day, are near the state objective of 100 gallons per person, per day.

Our new state-of-the-art \$110 million dollar waste water treatment plant currently produces 2.5 million gallons per day that is returned to the Lompoc Valley Aquifer. The water quality, of the waste water plant aquifer recharge water, exceeds the quality of water being pumped from city wells.

As a result of conservation and recharge, our well levels are near their historic high water levels. This letter will also serve as the response from our utility director.
