RECOMMENDATIONS:

C.A.	Recommendation:

That the Board of Supervisors adopt a resolution establishing a "No Parking" zone on Burton Mesa Boulevard in the Vandenberg Village area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Burton Mesa Boulevard is a major collector street running through Vandenberg Village. A request was received from a private individual regarding a driveway to the shopping center located on the north corner of the intersection of Constellation Road, Burton Mesa Boulevard and Apollo Way. The driveway is located on Burton Mesa Boulevard approximately 440 feet northwest of Constellation Road. The concern is that large tractor trailer trucks are commonly parked on the northeast side of Burton Mesa Boulevard close to the driveway, which inhibits the visibility of the driver trying to exit the parking lot. Other on street parking is readily available for the trucks.

The Santa Barbara County Traffic Section has performed a site visit to this location and determined that a no parking zone should be established on both sides of this driveway. Therefore, the Public Works Traffic Section has prepared the attached resolution establishing a no parking zone at the following location:

 On the northeast side of Burton Mesa Boulevard between a point 282 feet northwest of the centerline of Constellation Road and a point 572 feet northwest of the centerline of Constellation Road. Subject: No Parking on Burton Mesa Blvd
