That the Board of Supervisors:

- A. Approve the Project, Segovia Road ADA Improvements; County Project No. 862358; Third Supervisorial District;
- B. Authorize the Director of Public Works to advertise for bids to construct the Segovia Road ADA Improvements Project; County Project No. 862358; Third Supervisorial District;
- C. Find that pursuant to State CEQA Guidelines Section 15162, no substantial changes are proposed, and no new information of substantial importance has come to light regarding environmental effects of the project or of the sufficiency or feasibility of mitigation measures, and therefore the proposed actions are within the scope of the Isla Vista Master Plan Environmental Impact Report (03-EIR-08) adopted by your Board on August 21, 2007 pursuant to State CEQA Guidelines Section 15180, and that therefore no new environmental document is required.

Summary Text:

The project site is on the north side of the 6500 block of Segovia Road, between Embarcadero Del Mar and Embarcadero Del Norte, in the unincorporated area of Isla Vista. This project will install five-foot wide sidewalks; replace the existing driveway approaches with ADA compliant approaches, and install three curb ramps. Additionally, a five-foot sidewalk with retaining wall will be installed on the eastern side of Embarcadero Del Mar connecting the Segovia Road improvements with the existing sidewalks to the north on Embarcadero Del Mar. Each new driveway approach will require concrete or asphalt concrete conform pavement to match the adjacent private property grades. In cases where driveway conforms extends beyond the County right of way, a right of entry permit has already been acquired from the owner. Installations of these improvements are consistent with the goals of the Isla Vista

Master Plan and are funded by Measure A. Construction is anticipated to occur while UCSB is out for summer break, minimizing the impact to the community.

Background:

Implementation of sidewalk network improvements was a component of the Isla Vista Master Plan, 03-EIR-08 which was approved by your Board on August 21, 2007. Environmental review of the sidewalk construction under the California Environmental Quality Act (CEQA) has been performed pursuant to Public Resources Code Section 21090(b) in said Isla Vista Master Plan.
