**SUBJECT:** Transition of administrative responsibility for the Tri-County F.I.S.H Team and

acceptance of Grant Funds from the California Department of Fish and Game

#### **Recommendation(s):**

That the Board of Supervisors:

- A. Direct staff to extend the transition of administrative duties to the County of Ventura through the end of FY 05-06 (June 30, 2006) and authorize the Public Works Director to execute any necessary agreements to transfer administrative responsibilities for this project;
- B. Adopt the attached Resolution to accept the terms and conditions of Grant Agreement (#P0450013) with the California Department of Fish and Game to receive grant funding to fund administration of the Tri-County F.I.S.H. (Funding for Improved Salmonid Habitat) Team activities; and
- C. Authorize the Public Works Director or his designee to enter into Grant Agreement (#P0450015) and all other subsequent agreements or amendments to receive up to \$94,792.00 in funding for the project.

### **Alignment with Board Strategic Plan:**

The recommendations align with Goal No. 5: Maintain and Enhance the Quality of Life for all Residents.

## **Executive Summary and Discussion:**

On May 3, 2005, your Board authorized application of a grant for future TCFT work (beginning FY 06-07) and directed staff to request another agency assume administrative duties for that grant and the overall program beginning January 1, 2005. County staff have explored a number of options with the counties of San Luis Obispo and Ventura; Ventura County has offered to assume administrative responsibilities at the end of a transition period through FY 05-06 (June 30, 2006). The State will allow County of Ventura to substitute for Santa Barbara County for the May 3 grant application and accept the grant if awarded. The State will not allow Ventura County to substitute for Santa Barbara County in the agreement P0450013 which provides funding through FY 05-06.

Thus instead of a January 1, 2006 hand off of this project, a transition period until July 1, 2006 would take place and administrative responsibilities would then be taken by Ventura County.

As discussed in previous hearings and Board Letters, the County will still be involved as a member of the TCFT. As such the County's continued involvement would help protect the interest of the County and private land owners. In addition, staff will only support projects that have the land owner's support, whether that is a private property owner, or an agency.

#### **Mandates and Service Levels:**

Approval the transition of administrative duties would provide a continuous level of service for tri-county residents. Approval of the Grant will allow the TCFT to continue it efforts on permit streamlining and public information.
