Recommendation(s):

That the Board of Supervisors:

- A. Accept Notice of Completion for work performed by the Contractor, Granite Construction Company, and authorize Clerk to record; and
- B. Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, Granite Construction Company, in the amount of \$673,860.64.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No.2 to ensure the public's health and safety.

Executive Summary and Discussion:

As part of the Tajiguas Landfill Expansion Project it is necessary to stockpile excess soil. To allow for stockpiling, the landfill main access road was realigned. This project to realign the road was consistent with the environmental impact report for the Tajiguas Landfill Expansion Project.

The project was started in September, 2005, and was accepted by the Director of Public Works as complete on November 23, 2005.

This project was completed within the contract period and for an amount of \$673,860.64, which is within the approved contract amount of \$716,532.00 including contingency.

Mandates and Service Levels:

This project will not change the level of service.

Fiscal and Facilities Impacts:

Funds for this project were budgeted in the Resource Recovery and Waste Management Enterprise Fund 1930 Line Item Account 8200.
