- a) Receive and file the Santa Barbara County Planning Commission Action Letter from the December 4, 2024 hearing finding that the outlined Fiscal Years 2024-2029 Capital Improvement Program projects to be in conformance with the County Comprehensive Plan (Attachment A), and
- b) Determine that the proposed actions do not constitute a "Project" within the meaning of the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines §15378(b)(5) as they consist of organizational or administrative activities of government that will not result in direct or indirect changes in the environment; and that the proposed actions do not constitute "Approval" within the meaning of CEQA Guidelines §15352 as they do not commit the County to a definite course of action in regard to any project.

Summary Text:

Approval of today's actions will complete the review, analysis and actions required with the Fiscal Year 2024-2029 CIP Projects reviewed for conformity with the County Comprehensive Plan.

Background:

The Fiscal Years 2024-2029 Capital Improvement Program was presented to the Board of Supervisors on May 14, 2024. The approved Board action allowed General Services to refer the new CIP Projects to the Planning Commission and request analysis of these projects proposed for planning, initiation, or construction in future fiscal years for conformity with the County Comprehensive Plan per Government Code 65401 and 65402.

The applicable fiscal year 2024-2029 CIP Projects were provided to Planning and Development for review for conformity with the Comprehensive Plan. Planning and Development staff reviewed the proposed projects and provided the Planning Commission with a staff report that was reviewed and approved at the December 4, 2024, Planning Commission Hearing.
