Recommended Actions:

- a) Authorize and approve the Chair of the Board to execute an Agreement for Services of Independent Contractor with Astound Business Solutions, LLC., (Astound), a Delaware corporation, for the County's telephone services for a total maximum contract amount of \$342,000, beginning July 1, 2024, through June 30, 2029 (Agreement); and
- b) Approve and authorize the Chief Information Officer (CIO), or their designee, to order additional services in an amount not to exceed 10% of the contract amount, or \$34,200.
- c) Determine that the above recommended action is a government funding mechanism or other government fiscal activity, which does not involve any commitment to any specific project that may result in a potentially significant physical impact on the environment and is therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA Guidelines.

Summary Text:

This item is on the agenda to request that the Board of Supervisors (Board) authorize the Chair to enter into the Agreement with Astound for the provision of the County's dark fiber services for FY 24-25 through FY 28-29.

Background:

Astound (formerly Wave) has been providing dark fiber and ethernet network service for the County of Santa Barbara since 2018. Since its inception, this partnership has been integral to the operational infrastructure of our organization, facilitating seamless connectivity and robust data transmission capabilities between major campuses, to remote offices, and to the Internet. The key enhancements and provisions of the renewed contract reflect our commitment to optimizing network performance, maximizing operational efficiency, and delivering exceptional value to our organization.

Key Highlights of the Renewed Contract:

<u>Additional Bandwidth Allocation</u>: Recognizing the increasing demands on our network infrastructure, the renewed contract includes provisions for expanded bandwidth allocation. This augmentation enables our organization to accommodate growing data traffic, support emerging technologies, and enhance overall network performance.

<u>Cost Optimization Initiatives:</u> Through strategic negotiations and collaborative efforts, we have secured favorable pricing terms with Astound. These cost optimization initiatives not only result in significant savings for our organization but also ensure that we continue to receive high-quality network services without compromise.

<u>Continued Reliability and Quality of Service:</u> Building upon our longstanding partnership, the renewed contract reaffirms our mutual commitment to reliability and quality of service. With service level agreements (SLAs) in place, Astound remains dedicated to delivering best-in-class network services, ensuring uninterrupted connectivity and business continuity for our organization.

Narrative:

Funding to cover the costs is included in the IT Shared Services Internal Service Fund (ISF) rates allocated to departments, including funding to cover the 10% contingency amount of \$34,200 if it is determined that additional services are needed. The methodology used to determine the allocation is based on departmental device count. The agreement is at a monthly rate of \$5,700 (\$5,700 per month x 12 months = \$68,400 x 5 years = \$342,000). Current monthly costs are roughly \$13,000. By locking in pricing with this agreement, the County will be saving approximately \$7,000 a month (\$13,024 per month - \$5,700 per month = \$7,324 per month savings x 12 months = \$87,888 savings per year x 5 years = \$439,400).
