WHEREAS, David serves as the Hearing Support Supervisor and the Recording Secretary for the County and the Montecito Planning Commissions.

WHEREAS, in his role as Recording Secretary he has played an instrumental and critical role in transitioning very quickly to, and maintaining, remote hearings for both Planning Commissions during the COVID-19 pandemic.

WHEREAS, David has consistently performed under pressure and amidst frequent challenges during remote hearings to keep the them on track and orderly through coordinating with CSBTV staff, guiding the Chairs, responding to questions from the Commissioners, queuing up presentations by staff and applicants, organizing and implementing public comments via video, emails, and phone calls.

WHEREAS, in his role as Hearing Support Supervisor, David guided the transition of other hearing bodies to remote hearings and consistently provides exceptional leadership and guidance to his team that support multiple hearing bodies or advisory committees.

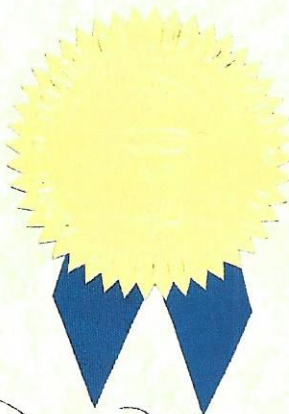
