Title: Increase appropriations of \$740,800 from the California Department of Forestry and Fire Protection.

Budget Action: Increase appropriations of \$740,800 in the Fire Department, Fire Protection District Fund for Capital Assets funded by unanticipated revenues from the California Department of Forestry and Fire Protection (CAL-FIRE).

Justification: The acceptance of \$904,677 in grant funds to purchase equipment and implement various fuel treatments designated by the Santa Barbara County Unit Strategic Fire Plan and Agreement from the grant approval date, December 12, 2025, through February 15, 2029, will increase appropriations of \$740,800 in Fiscal Year 2025-26 for Capital Assets (Equipment). Fire intends to complete the project by the end of Fiscal Year 2026-27. The remaining balance of \$163,877 will be budgeted in Fiscal Year 2026-27; any unspent funds will be carried over into Fiscal Year 2027-28, which is part of the performance period.
