Recommended Actions:

- 1. Approve and execute a Memorandum of Understanding with Catholic Healthcare West, dba Marian Medical Center (a local vendor), for the provision of crisis intervention services in North Santa Barbara County, effective July 1, 2008.
- 2. Authorize the Director of ADMHS to approve amendments to the MOU, provided that any such amendments do not exceed ten percent (10%) of the annual dollar amount.

Summary Text:

The Memorandum of Understanding (MOU) sets forth the agreement between Marian Medical Center (Marian) and the County Alcohol, Drug, and Mental Health Services (ADMHS) department regarding North County crisis services. Under this MOU, Marian will provide a monthly grant to ADMHS to offset the costs of operating the outpatient program and providing services for crisis patients at the Crisis and Recovery Emergency Services (CARES) facility in North County.

Background:

Marian's Emergency Department (ED) provides services to a significant population of medically underserved individuals who require crisis intervention services for alcohol and other drug (AOD) and

mental health conditions. Providing AOD and mental health services to non-emergency patients strains the ED's resources available to provide medical care to urgent patients. An estimated seven individuals visit Marian daily needing care for AOD intoxication, psychiatric crisis, or some combination of the two. On average, one North County resident is hospitalized every day for psychiatric care.

ADMHS staff members provide services to Marian patients experiencing AOD and/or mental health conditions. ADMHS personnel evaluate the need for involuntary hospitalization and coordinate between the various service providers including Practitioners, Mental Health Assessment Team ("MHAT"), hospital personnel, and law enforcement. The increased availability of CARES will help divert clients experiencing crisis from requiring services at the hospital and reduce the burden they place on Marian's resources. In return, Marian has agreed to provide a monthly grant to ADMHS in the amount of \$6,000 to offset some of the CARES outpatient program operating costs. The CARES North facility is located at 212 Carmen Lane, Santa Maria. ADMHS and hospital staff will continue to work cooperatively to ensure effective service delivery at Marian.

Performance Measure:

Approval of the recommended action will help ADMHS meet the following **Recurring Performance Measures:**

RPM 0238: Avoid hospitalization and stabilize community members in crisis such that 80% of the 300 residents arriving at North County CARES in crisis are not hospitalized within 24 hours of a crisis contact.

RPM 0236: To calm and contain volatile behaviors, provide prompt assessment, supervision, oversight, and referral to community members who arrive at North County CARES with mental health and/or substance abuse problems.
