WHEREAS, the County of Santa Barbara (COUNTY) and Celeste Manolas (CONTRACTOR), 1051 La Luna, Ojai, CA 93023, entered into a contract dated November 10, 2009, for the not-to-exceed amount of TWO HUNDRED TWELVE THOUSAND SEVEN HUNDRED EIGHTY FOUR DOLLARS (\$212,784) for Services to the County, (AGREEMENT); and

WHEREAS, an error in the original contract resulted in an unintended switch in the amount of earned leave hours in the third fiscal year of the contract with that of the first fiscal year of the contract.

NOW, THEREFORE, the Agreement is hereby amended as follows:

Section 1:

Exhibit B of said Contract is hereby amended to read as follows:

Compensation

COUNTY shall pay CONTRACTOR for professional services pursuant to this Agreement upon biweekly submission by CONTRACTOR of a timesheet, and such payment shall be subject to deductions and withholding of state and federal taxes. In no event shall the compensation payable exceed the total sum of \$212,784 without written amendment. This not to exceed amount includes the following:

- \$196,416.00 for 3,840 hours of work by CONTRACTOR at a rate of \$51.15 per hour.
- \$8,184 per year for 160 hours per year of paid leave paid via payroll.
