<p style="text-align: center;"><b>NOTICE OF PUBLIC HEARING REGARDING ISSUANCE OF MULTIFAMILY HOUSING REVENUE BONDS FOR THE RESIDENCES AT DEPOT STREET</b></p> <p>NOTICE IS HEREBY GIVEN that, at 9:00 a.m., or as soon thereafter as the matter can be heard, on Tuesday, February 6, 2018, at the County Administration Building, Board Hearing Room, Fourth Floor, 105 East Anapamu Street, Santa Barbara, California, the Board of Supervisors of the County of Santa Barbara (the "County") will conduct a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986, at which it will hear and consider information concerning a proposed plan of financing providing for the issuance by the Housing Authority of the County of Santa Barbara of multifamily housing revenue bonds in one or more series issued from time to time, including bonds issued to refund such revenue bonds in one or more series from time to time, and at no time to exceed \$25,000,000 in outstanding aggregate principal amount, to finance the acquisition and construction of a 80-unit multifamily rental housing project located at 301 North Depot Street, Santa Maria, California. The facilities are to be owned by The Residence at Depot Street, L.P. (the "Borrower"), initially operated by the Housing Authority of the County of Santa Barbara, with certain services provided by Surf Development Company, and are generally known as The Residences at Depot Street (the "Project").</p> <p>Those wishing to comment on the proposed financing and the nature and location of the Project may either appear in person at the public hearing or submit written comments, which must be received by the County prior to the hearing.
