Hearing on the request of Ronn Carlentine, agent for the General Services Department, Office of Real Estate Services, to consider Case No. 12GOV-00000-00010, [application filed on March 26, 2012], for a determination that the proposed acquisition of an easement to allow the County access to maintain and repair the Orcutt Old Town Clock is in conformity with the Comprehensive Plan of the County of Santa Barbara pursuant to Government Code Section 65402(a). This site is identified as AP No. 105-092-002, located at 120 E. Clark Avenue, in the Orcutt area, Fourth Supervisorial District

Dear Mr. Carlentine:

At the Planning Commission hearing of May 2, 2012, Commissioner Valencia moved, seconded by Commissioner Blough and carried by a vote of to 5 to 0 to:

- 1. Determine that the proposed acquisition of an easement to allow the County access to maintain and repair the Orcutt Old Town Clock is in conformity with the Comprehensive Plan and the Orcutt Community Plan; and
- 2. Transmit the conformity report required by Government Code Section 65402(a) to Ronn Carlentine, agent for the General Services Department, Office of Real Estate Services and the Board of Supervisors. The memo dated May 2, 2012 and the letter reflecting the Planning Commission's action shall constitute the required report.

The Planning Commission action relative to Government Code Section 65402(a) is advisory in nature; therefore the appeal procedure is not applicable. Your Commission's determination will be forwarded to the General Services Department and the Board of Supervisors.
