WHEREAS, the County of Santa Barbara has an active utility undergrounding program pursuant to Chapter 34 of the County Code, for the removal of poles, overhead wires, and associated overhead structures and underground installation of such utilities; and

WHEREAS, the California Public Utilities Commission controls electrical underground construction funding, allocated under Tariff Rule 20A, pursuant to Decision No. 73078 of Case 8209, and allows municipalities to assign uncommitted credits to other municipalities; and

WHEREAS, the County has certain uncommitted credits in its Pacific Gas and Electric Company territory credit balance; and

WHEREAS, the City of Solvang has requested an assignment of County of Santa Barbara Rule 20A credits in order to complete a utility undergrounding project located at the intersection of Mission Drive and Fifth Street in its jurisdiction; and

WHEREAS, this resolution is to approve the assignment of County of Santa Barbara County Rule 20A credits to the City of Solvang; and

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Supervisors of the County of Santa Barbara, State of California, as follows:

1. That the County of Santa Barbara approves the assignment of \$550,000 of Pacific Gas and Electric Company Tariff Rule 20A utility undergrounding credits to the City of Solvang.

2. Assignment of said Pacific Gas and Electric Company Tariff Rule 20A utility undergrounding credits is in exchange of \$275,000 as approved by the Solvang City Council on March 27, 2017.

3. Find that the exchange is for public purposes as administered by the Public Works Department, which is of interest and benefit generally to the people of Santa Barbara County.
