This project involves the replacement of sewer lift station and effluent lines at Lake Cachuma County Park. The project also includes the installation of backup generator and automated switches for the lift station.

Background:

This project involves the replacement of sewer lift station and effluent lines at Lake Cachuma County Park. The existing facility is in excess of 30 years old and will be affected by the impending 3-ft lake surcharge announced by Cachuma Operation and Maintenance Board (COMB). Replacement will preclude accidental spill. The project also includes the installation of backup generator and automated switches for the lift station. Currently the generator is rented (if available) during the power outages. Purchase of generator and their connections to existing lift station will preclude renting of equipment and potential hazardous spill/overage of sewer from lift station.
