Recommended Actions:

It is recommended that the Board of Supervisors:

- a) Adopt a Resolution approving, ratifying, and authorizing the District Attorney to execute a Grant Agreement Amendment with the California Department of Insurance for the Workers' Compensation Insurance Fraud Program for the period of July 1, 2018 through June 30, 2019 in the amount of \$10,983.00, for a new total of \$403,104.00 for the current fiscal year; and
- b) Determine that the above action is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4), because it consists of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment.

Summary Text:

The Workers' Compensation Insurance Fraud Program is designed to investigate allegations of workers' compensation fraud, arrest offenders, prosecute violators, and seek restitution for funds lost through fraudulent claims or business practices. Board approval is required to receive additional grant revenue for Fiscal Year 2018-19. Approval of the Recommended Actions will authorize the District Attorney's execution of the Grant Award Amendment, allowing the Department to receive the additional funds.

Background:

Workers’ Compensation fraud is a community and statewide issue that impacts industry, employers, the medical profession, insurance companies, employees, and local businesses. There is a direct correlation between workers’ compensation fraud and increases in insurance premiums. Fraud results in higher insurance premiums for all employers, which are then passed on to the consumer through an increase in costs of goods and services we use every day. These factors led the Santa Barbara County District Attorney to develop the Workers’ Compensation Fraud Program, which brings together local businesses, the California Department of Insurance (CDI), and the District Attorney to tackle Workers’ Compensation Fraud. The Board of Supervisors originally authorized this program in November 2003, making this the 16th year of the program in Santa Barbara County.

The Workers’ Compensation Fraud Program is financed through fees assessed by the State Insurance Commissioner as part of the workers’ compensation insurance rates. The long-term goal of this initiative is to reduce workers’ compensation insurance fraud in Santa Barbara County through crime prevention and deterrence, to be accomplished through a combination of community education and criminal prosecution of fraud cases.

The District Attorney’s Workers’ Compensation Fraud Unit currently has four felony cases and one misdemeanor case in the court system, three filed cases pending felony warrants, and 10 open investigations. Two of the pending investigations involve multi-defendant medical provider fraud. It is estimated that one of these cases, which involves over \$87 million dollars in potential fraud, will be ready to file before the end of the calendar year. In addition, Labor Code program efforts continue to educate and, if necessary, prosecute employers who do not have workers’ compensation insurance. The additional funds received via this amendment will be used specifically for enhanced investigation and prosecution of Workers Compensation Insurance fraud.

Two Deputy District Attorneys (including one Contractor on Payroll) are assigned to this grant, with one part-time attorney in Santa Barbara and a lead Deputy District Attorney to oversee the grant Countywide. One District Attorney Investigator is also assigned to the program, as well as two Legal Office Professional Seniors who assist with the program. The Fiscal Year 2018-19 grant award is \$403,104, which includes \$331,492 in Salaries and Employee Benefits and \$48,532 in operating costs, and \$23,080 in overhead associated with the program.

Key Contract Risks:

The District Attorney has been awarded this grant annually since the Workers' Compensation Insurance Fraud Program was first established. There is minimal risk to the County.
