Dear Board of Supervisors,

I am writing regarding your hearing tomorrow on retail stores. In addition to the awful air quality and odors, night lighting and noise we are experiencing living next to industrial-level grow operations, the Toro Canyon Community Plan and the Summerland Community Plan are both unincorporated county areas now under consideration for allocating a retail cannabis store. For reasons that are unclear to me, I understand that unincorporated Montecito is not being considered by the county for the 1st District retail sales area - that is quite an interesting omission, though god knows I wouldn't wish this on Montecito either!

Despite requests by the Santa Barbara Coalition for Responsible Cannabis, residents in the affected community plan areas were not noticed regarding this hearing on potential cannabis retail sites - that seems like a missed opportunity to engage the community.

I wanted to express my view that cannabis stores are incompatible with the stated goals and objectives of our area's community plans here in the 1st District. In addition, I object to the tragic concentration of negative impacts in such a small area of the county here in Carpinteria Valley.

In the words of Crosby Stills & Nash, "haven't we lost enough?" We have already become a garbage dump for this incredibly un-neighborly industry. Must the torture of our quaint, beachy, family-friendly town now continue by erecting a retail shrine in its name?
