A. Execute the attached original and duplicate original Lease Agreement between the Redevelopment Agency and Paradise Ivy, LLC, for the Agency's use of approximately 2,000 square feet of office space located at 909 Embarcadero del Mar, Isla Vista, for a period from July 15, 2008, through December 30, 2008, at a monthly base rent of $\$ 2,000.00$. The proposed office space will be used by Redevelopment Agency and Public Works staff for project oversight and community outreach and public parking during construction.

## Summary Text:

The proposed lease will allow the Redevelopment Agency to establish a temporary office, and public parking lot, in Isla Vista during construction of the Pardall Road Enhancement Project. The Project is scheduled to begin in August 2008 and end in December 2008. The proposed office space will be used by Redevelopment Agency and Public Works staff for project oversight and community outreach during construction. The leased site also includes a parking lot, which will be used for short term storage and public parking for downtown Isla Vista businesses.

The lease is anticipated to last the duration of construction of the Pardall Enhancements Project beginning on July 15 and lasting through December 30, 2008. The total cost of the lease for $51 / 2$ months will be $\$ 11,000$.

Background: The County Redevelopment Agency is funding construction of the Pardall Road Enhancement Project, anticipated to begin construction in August 2008. The project will reconstruct and expand sidewalks, reconstruct the roadway, install street lights, plant street trees, and improve pedestrian, bicycle, and motorist accessibility and safety. The project will also improve emergency vehicle access along Pardall Road, improve drainage, upgrade water service, and address ADA accessibility deficiencies. Pardall Road extends from the UCSB Campus to the east to Camino Pescadero in the west. The project is identified in the Isla Vista Master Plan.
