Acute myocardial infarction. Myocarditis/pericarditis. Autoimmune disease. Death. Pregnancy and birth outcomes. Other acute demyelinating diseases. Non-anaphylactic allergic reactions. Thrombocytopenia. Disseminated intravascular coagulation. Venous thromboembolism. Arthritis and arthralgia/joint pain. Kawasaki disease. Vaccine enhanced disease. Multisystem Inflammatory Syndrome in Children.
